

C-REMARKS:

- 80% (4550sets) finished packed into cartons when inspection, the rest units were finished the stitching process and 1. under clean, thread end cut and self-inspection, packing etc.,. Please see section D for the actual status.
- 2. No fabric cutting scale was available at factory for checking the fabric weight (GSM).
- 3. Some information (item no, carton weight and carton number) on shipping mark of carton was not filled by factory when inspection, they claimed they would write it before shipment.
- For size measurement, found four points of size were out of tolerance (Front Rise -0.3 to -0.5", back Rise:-0.3 to 4. -0.65", Waist Band Height: +0.375", Inseam: +0.3 to 0.35"). Please see table G-1 for detail.
- Found export cartons were expanded for size 1X to 4X due to not enough empty for packing. Factory claimed they 5. would replace then with the large size cartons before shipment.



Note:

- Factory provided approval sample for compare when inspection. But only the approval sample for 1. (54164BLK/54172BLK) was available for compare and found the bulk-product were closed to the approval sample. No approval sample available for rest of two colors. please refer to actual photo on report
- 2. Factory provided pre-packing list for reference for inspection due to the final quantity was not counted by factory and the final-packing list can not issue when inspection.
- For the same set of products (Jacket and pant), Found the jacket and the pant color was similar, Not found the dye 3. lot problem for the same set for the inspected samples.
- For workmanship, found some of the defects from inspected samples. As per TTS AQL standard, it is acceptable, 4. but the final decision need confirm by client. Please see section F for actual finding.
